PRIVACY STATEMENT

Preface

Auckland Coastguard Inc. (Coastguard Auckland) is committed to safeguarding the personal information of those with whom it deals with openness and transparency in compliance with the New Zealand Privacy Act 2020.

The following Privacy Statement ('Statement') explains Coastguard Auckland privacy practices, as to what information may be collected from you, how such information will be used by Coastguard Auckland and/or other persons or entities, with whom such information may be shared, your choices regarding the collection, use and distribution of such information, your ability to access or correct such information and the security procedures that Coastguard Auckland have implemented to protect your privacy.

Privacy Statement

Coastguard Auckland is committed to safeguarding the privacy of individuals who visit its website for event registration, buying products, donating, or searching for information and/or application purposes.

Coastguard Auckland understands that personal information should be kept private. This Statement complies with the New Zealand Privacy Principles as contained in the New Zealand Privacy Act 2020, and explains how Coastguard Auckland:

- Collects personal information
- Uses and shares your personal information
- Processes payments
- Stores personal information
- Uses cookies
- May use the Google Analytics service
- Will not be responsible for personal information collected through linked third-party websites
- Allows you to access/amend your personal information
- Provides you with contact for further information.

By using or accessing the website (whether by your mobile phone, tablet, smartphone, PC or any other means), you are deemed to have agreed to be bound by this Statement.

Links to other sites and third-party providers

This site, any newsletters or any other communications Coastguard Auckland provides to you may contain links to third party websites. Coastguard Auckland may also use some third-party providers to manage some of our engagement processes and services, such as newsletters, event registrations, and fundraising platforms. Unless expressly stated otherwise, these websites have not been

developed by, nor are controlled by Coastguard Auckland. While Coastguard Auckland takes steps to ensure that any providers Coastguard Auckland uses can protect the personal information they process for Coastguard Auckland, there is no implication that Coastguard Auckland checks, endorses, approves or agrees with the privacy practices of the third-party websites linked to. Coastguard Auckland encourages you to be aware when you leave a Coastguard Auckland website and to read the privacy policies of each website you visit.

Links to social network platforms

Coastguard Auckland uses social networking services such as Facebook, LinkedIn and Instagram to communicate with the public about Coastguard Auckland work, to raise awareness of events and for fundraising campaign purposes. When you communicate with Coastguard Auckland via these services, the social networking service concerned may collect your personal information for its own purposes.

These services may track your use of Coastguard Auckland websites on those pages where their links are displayed. If you are logged in to those services (including any Google service) while using a Coastguard Auckland site, their tracking will be associated with your profile with them.

These services have their own privacy policies / statements which are independent of Coastguard. They do not have any access to the personal information Coastguard Auckland hold on our systems.

What personal information does Coastguard Auckland collect and why?

The personal information Coastguard Auckland may collect from you directly, or indirectly, includes:

- Your name
- Your contact details, including address, email or phone number
- Financial details if you donate to Coastguard Auckland
- Details of any events you have registered for, including dietary requirements
- Any questions or comments you submit via Coastguard Auckland social media platforms
- Your responses to surveys or group discussions
- Information about your use of Coastguard Auckland website

Coastguard Auckland may collect personal information about you (such as your first and last name, mailing address, telephone number, e-mail address and credit card number), directly from you, when you use the website or interact with social media or digital advertising, over the phone, in person, by letter or email, including when:

- You complete an application form
- You register for an event or a delegated third-party register on your behalf
- You subscribe to a newsletter or an emailing list
- You deal with Coastguard Auckland over the telephone
- You email Coastguard Auckland
- You provide Coastguard Auckland with feedback
- You complete online surveys, competitions or enquiry forms
- You ask Coastguard Auckland to contact you after visiting a Coastguard Auckland website
- You contact Coastguard Auckland for any other purpose, and Coastguard Auckland provides information or services to you.

Coastguard Auckland will only use and disclose your personal information for the purposes for which it was collected (or otherwise as required or authorised by law). This may include using your personal information for the following purposes:

- To provide you with products or services and to personalise your experience when browsing the website;
- To undertake customer service activities, such as responding to any queries, comments or complaints you may have;
- To administer website services, including processing any searches or requests for information about Coastguard Auckland services;
- To maintain and develop Coastguard Auckland systems, including testing and upgrading them;
- To enable Coastguard Auckland to monitor, review and improve our services, and communicate with you about them;
- For Coastguard Auckland administrative purposes and for internal record keeping;
- To comply with relevant laws and regulations;
- To anonymise data for use in such a manner that you cannot be identified for purposes such as online advertising / re-marketing, Search & Rescue research, and
- For any other specific purpose which Coastguard Auckland notifies you of at the time your personal information is collected.

Online advertising, Re-Marketing and Third-Party Tracking

We may use Google Ads, Facebook, digital advertising networks and other platforms to raise awareness of Coastguard Auckland services and promote events, fundraising and education activities and events, some of which is done through re-marketing.

Lookalike audiences

For marketing or re-marketing purposes, we may use information about our supporters to create 'lookalike' or similar audiences of shared interests or similar demographics via these platforms.

Cookies and Analytics

Coastguard Auckland uses cookies and analytics tools on Coastguard Auckland website to:

- Allow you to navigate and use key website features
- Authenticate, and
- To collect information about how you use the website.

The following information is collected about your use of Coastguard Auckland website (though please note, Coastguard Auckland may associate information with your identity):

- Your IP address
- The search terms you used
- The pages you accessed on Coastguard Auckland website and the links you clicked on
- The date and time you visited the site
- The referring site or social media platform (if any) through which you clicked to the Coastguard Auckland website
- Your operating system (such as Windows)
- The device via which you accessed the site (such as mobile, tablet, PC); and
- Your web browser (such as Chrome or Safari).

A cookie is a small data file that the site sends to your browser, which may then store it on your system for later retrieval by the site. Information supplied by the cookies and session information can help Coastguard Auckland to analyse the profile of our site's visitors and helps Coastguard Auckland to provide you with a better user experience. They may not track your activity before or after you leave a Coastguard Auckland site.

Coastguard Auckland may use the Google Analytics and other digital advertising tools which may issue cookies from their own servers and which are able to track visitor activity through a Coastguard Auckland website. For more information on how Google Analytics collects and processes data, please click here. Please refer to Google's Privacy Statement for more information.

From time to time, Coastguard Auckland may also contact you for market research purposes or to provide you with information about new services, special offers and promotions. This may include information about Coastguard Auckland programmes, research funding, events, donor and fundraising activities. Coastguard Auckland will give you the opportunity to opt out of receiving such direct marketing or market research content.

If you do not want your personal information to be collected, please do not submit it to Coastguard Auckland. Please note that if you elect not to provide certain personal information to Coastguard, Coastguard Auckland may not be able to provide you with the services or information you require.

Payments

Online payments are made securely through payment solutions providers such as Stripe and Windcave. We vet and choose payment providers based on PCI compliance and we rely on them to meet data security obligations.

Does Coastguard Auckland share or disclose personal information?

For the purposes Coastguard Auckland have described, Coastguard Auckland may disclose your personal information:

- To Coastguard Auckland suppliers (including service and other content providers), contractors, agents and business partners who help Coastguard Auckland administer the website and/or deliver services to you;
- To Coastguard Auckland professional advisers;
- Where you have otherwise consented; or
- As otherwise required or authorised by law.

Coastguard Auckland may also disclose your personal information to anyone who hosts or maintains data centres, service platforms and other infrastructure and systems on behalf of Coastguard, where your personal information is processed and/or stored.

Coastguard Auckland will take all reasonable steps to ensure that the persons and organisations to whom Coastguard Auckland discloses personal information are bound to protect the privacy of that personal information according to the New Zealand Privacy Act 2020. Please note that some of the persons to whom Coastguard Auckland discloses personal information may be situated outside New Zealand. Our website and systems may also be based on servers located outside of New Zealand.

If you have shared your information with Coastguard Auckland regarding any personal stories relating to services Coastguard Auckland has provided, Coastguard Auckland will only share these stories (in any way, shape or form) with your permission. This includes any images or video footage.

How does Coastguard Auckland protect your personal information?

Coastguard Auckland takes all reasonable measures to ensure the security of your personal information that is held by Coastguard Auckland from such risks as loss, misuse, unauthorised access, disclosure, alteration and destruction. Coastguard Auckland reminds you, however, that the internet is not a completely secure environment and although all reasonable care is taken, Coastguard

Auckland cannot warrant or guarantee the security of information that you provide to Coastguard Auckland via electronic means between you sending it and it being received by Coastguard Auckland.

For how long does Coastguard Auckland hold personal information?

Coastguard Auckland will keep your personal information for only as long as is necessary to achieve the purpose for which it was collected.

Changes to this Privacy Statement

Coastguard Auckland may modify this Statement from time to time and if Coastguard Auckland does so Coastguard Auckland will post any updated Statement on the website. Coastguard Auckland encourages you to check the website periodically to ensure that you are aware of the terms of Coastguard Auckland's current Statement.

How can you access and correct personal information?

If you wish to access your personal information or if you identify any inaccuracy in your personal information and wish to make a change to, or would like to verify such information, please contact Coastguard Auckland so that we may update Coastguard Auckland records. Coastguard Auckland contact information is set out below. Coastguard Auckland notes that it is not required to provide access to information in certain situations, but if Coastguard Auckland refuses access, Coastguard Auckland will give you our reasons for doing so.
